**ORDER**

As per GO read above,the under mentioned candidate who is presently working as Driver Gde I NCC Dept has been granted appointment to the post of LD Clerk changing his category as a special case under Section 47 of Persons with Disabilities Act 1995 by protecting his present pay considering the recommendations made by the undersigned. He has been appointed as the most junior LDC in the Dept.

2. Sri Vijayan AK while working at 27(K) Bn NCC,Palakkad met with an accident while on official duty and sustained serious injury and underwent 4 surgeries whereby his below right knee was amputated.Since the incumbent was totally unable to discharge his present duty,he had requested for category change and the same has now been approved by Govt.

3. In the above circumstances the candidate shown above is appointed temporarily as Lower Division Clerk (Ex-Servicemen - Category Change on Medical Compassionate Ground) in NCC Dept in the scale of pay of Rs. 9940-16580/- as junior most and posted in the office of 27(K) Bn NCC, Palakkad in the existing vacancy in pursuance of GO read above.

4. The above mentioned candidate is directed to report before the Commanding Officer, 27 (K) Bn NCC, Palakkad within 15 days on receipt of this proceedings with necessary documents in original to prove his date of birth, qualifications and in case of candidate whose community is noted in the appointment order, his community certificate, Disability Certificate from Medical Board, Non Creamy Layer Certificate etc also to be produced. He is also required to produce a Medical Certificate of health in original from a Medical Officer not below the rank of an Assistant Surgeon having MBBS Degree, failing which he will not be admitted for duty.

5. The appointment of the candidate is temporary under clause (i) of Sub Rule (a) of the Rule 9 of the General Rules of the Kerala State and Subordinate Service Rules 1958 as provided for in Rule 10 (b) of those Rules and also subject to satisfactory report in Police verification later regarding his character and antecedents. The service of the candidate is subject to Rule 3 (c) of the General Rules of the Kerala State and Subordinate Service Rules 1958.

6. His service will be regularised with effect from the date of his appointment subject to satisfactory verification report from the Police, and he will be on probation in the cadre of Lower Division Clerk for a period of two years on duty within a continuous period of three years from the date of joining duty.

7. The Head of Office will obtain the endorsed proforma duly filled in by the candidate before he is allowed to join duty (Proforma available in NCC website). If there is any discrepancy the candidate should not be allowed to join duty and the fact should be reported forthwith. The original Community Certificate, Non-Creamy Layer Certificate as applicable may be verified at the time of joining duty. The date of joining duty should be reported promptly.

8. As per GO (P) No.20/2011/P&ARD dated 30.06.2011, the candidate is also directed to affix his thump impression on the medical fitness certificate along with an attested copy of photograph. Service book in respect of the individual may be opened within one week from date of joining duty.

9. The candidate should report for duty within 15 days on receipt of this Order, failing which action will be taken to cancel the appointment without further notice.

Note: - 1. The Head of Office will obtain SPARK FORM NO1 duly filled for registering in the SPARK system to obtain Permanent Employment Number (PEN).  
2. The Head of Office will obtain application for allotment of Permanent Retirement Account Number (PRAN) from the Individual vide GO (P) No. 149/2013/Fin dated 03.04.2013.
