ORDER

1. The above mentioned candidates are directed to report to the Commanding Officer of the concerned units **within 15 days** on receipt of this proceedings with necessary documents in original to prove their date of birth, qualifications and in case of candidate whose community is noted in the appointment order, his community certificate, Non – Creamy Layer Certificate etc also to be produced. They are also required to produce **a Medical Certificate** of health in original from a Medical Officer not below the rank of an Assistant Surgeon having MBBS Degree and **two character certificates from gazettes officers**, failing which they will not be admitted for duty.

4. The appointment of the candidates are temporary under Rule 9 (a) (i) of the General Rules of the Kerala State and Subordinate Service Rules 1958 as provided in the Rule 10 (b) of the above rules and also subject to satisfactory report in Police verification later regarding their character and antecedents. The service of the candidates are subject to Rule 3 (c) of the General Rules of the Kerala State and Subordinate Service Rules 1958.

5. They will be on probation in the cadre of Last Grade Servant for a period of one year on duty within a continuous period of three years from the date of joining duty.

6. The Head of Office concerned will obtain the endorsed proforma duly filled in by the candidates before they are allowed to join duty. Community certificates of the candidates belong to Schedule Cast and enclosed and the same may be verified at the time of joining duty. The scanned copies of identification certificates of the candidates are also enclosed for verification of photograph and signature of the candidates and the fact may be recorded on the identification certificate itself. If there is any discrepancy the candidate should not be allowed to join duty and the fact should be reported forthwith. After the candidate is allowed to join duty, the identification certificate verified and found acceptable may be kept pasted in his service book. The original community certificate, Non creamy layer certificate as applicable may be verified at the time of joining duty. **The date of joining duty should be reported promptly.**

7. As per GO (P) No.20/2011/P&ARD dated 30.06.2011, the candidate is also directed to affix his thump impression on the medical fitness certificate along with an attested copy of photograph. Service book in respect of the individual may be opened within one week from the date of joining duty. **Attested copies of pages of service book containing name, address, thump impression, signature and personal identification marks are to be forwarded to this Directorate along with photocopy of identification certificate duly verified by the Commanding Officer and joining report, for onward submission to Kerala Public Service Commission.**

8. The candidates should report for duty within **15 days** on receipt of this order, failing which action would be taken to cancel the appointment without further notice.

Note: - 1. The Head of Office will obtain SPARK FORM No 1 duly filled for registering SPARK system to obtain Permanent Employment Number (PEN).
2 Identification certificate of the candidate should also be returned along with the NJD report if any.
