**AWARDING OF GRACE MARKS TO THE NCC CADETS IN THE SSLC/THSLC  
EXAMINATION FOR THE YEAR 2014**

1. As per Govt of Kerala Orders No. GO(MS) 72/06/G.Edn dated 18.02.2006 and GO (MS) No. 87/2012/Gen dated 24.03.2012, NCC Cadets who fulfill the following criteria are eligible for 10% / 5% Grace Marks in the SSLC/THSLC Examinations. The last date of application received in unit on **05 Mar 2014**.

- (a) Passed "A" Certificate Examination.
- (b) Represented the State at RDC/IDC/BLC/NSC/VSC/TSC/RCTC/NIC/ALC/ All India Trekking Expedition any one (10%) and cadets those who have 75% and above parade attendance are eligible for 5%gracemarks
- (c) Held the rank of Cpl or its equivalent and above.

2. Applications are invited from the eligible NCC Cadets for award of grace marks in the SSLC/THSLC Examinations during the current academic year. All COs are requested to obtain applications from the eligible Cadets in the prescribed proforma as per appendix "A" along with copies of attested NCC certificates including copy of SSLC/THSLC, Admission Ticket duly attested by Head of Institution in **three copies** and forward **two** to their respective Group Headquarters on or before **07 Mar 2014**. Group Commanders are requested to consolidate and forward **one** copy of applications to this Directorate duly completed on or before **11 Mar 2014**. **The following points be ensured before applications forwarded to Dte:-**

- (a) Instructions issued vide the Dte letter under reference is strictly adhered to.
- (b) Veracity of documents supported is verified as per records.
- (c) Details of the Cadets are verified from Enrolment form.
- (d) Nominal roll of cadets are to be forwarded directly to this Directorate in **excel worksheet** prepared by unit as per proforma attached in **appendix 'B'** for 5% and 10% separately to this email Address : [gracemarksslc@gmail.com](mailto:gracemarksslc@gmail.com)
- (e) **Ensure name of cdt and Register Nos are typed in the Nominal Roll as printed in the Admission Ticket only**
- (f) Ensure eligible applications are forwarded in one copy to this Directorate on or before 11 Mar 2014
- (g) Consolidate / Individual Attendance Certificate of cadets to be attached for 5% Grace Marks.


3. Necessary instructions be given to all ANOs/Institution to submit the application thoroughly scrutinized well in time to enable Directorate to forward the same to Director of Public Instructions before last date so that the cadet can avail the facility as authorized by Govt.
