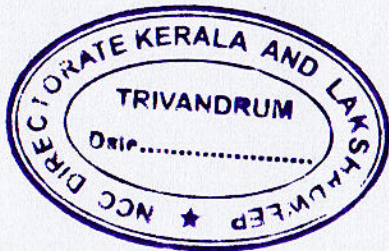
4. One vacancy is kept unfilled for want of declaration of Probation of Sri. Sasikumar K, who is in next line of seniority of Jr. Supdts.
