ORDER

Government had issued orders for 10 % by transfer appointment of Low paid employees to LDC/ LDT vide GO's read 2nd to 4th cited above. Based on the above orders, this Directorate prepared a state wide seniority list of Low paid employees eligible for promotion to the post of LDC/LDT vide proceedings cited 6th above and appointed Sri. Babu PV, Lascar Gd-II, 10 (K) Bn NCC as LD Typist & posted to 1 (K) BN NCC, Varkala vide proceedings cited 6th.

2. Sri. Anil Kumar B, OA, 3 (K) Girls Bn NCC submitted a complaint regarding the qualifications prescribed for by transfer appointment to the post of LD Typist. Sri. Babu PV, Lascar Gd-II passed English typewriting Lower Grade KGTE on May 1978 and did not produced "Computer Word Processing or its equivalent" certificate alongwith his application. On scrutiny of the qualifications prescribed to the post of LDT vide GO read 1st above, it was found that those who have passed the KGTE Typewriting before January 2002 should possess/produce separate certificate in "Computer Word Processing or its equivalent".

3. This Directorate issued notice to Sri.Babu PV, LDT to produce any proof to substantiate his qualification as on 04 Aug 2015 as per GO cited 1st above and the individual has submitted computer word processing certificate issued by Rajeswary Educational Training Centre, Kayamkulam. On scrutiny of the above certificate, same was not found listed in the name of institutions authorised/accepted by KPSC. This Directorate sought clarification from the Secretary, KPSC regarding the acceptance of the above certificate and they have informed that the list of institutions accepted by the Commission has been notified vide gazette dated 10.09.2014 vide their letter cited 8th above and the same is published in their official website. Rajeswary Educational Training Centre, Kayamkulam is not listed in the above notification.

4. In the above circumstances, the promotion orders issued vide Proceedings cited 6th above in respect of Sri.Babu PV is hereby cancelled and Sri.Babu PV, LDT, 1 (K) Bn NCC, Varkala is reverted to the post of 'Lascar Grade-I' and posted to **16 (K) Bn NCC, Kottayam**.

5. Necessary entries will be made in the service book of Sri. Babu PV in this regard under proper attestation.
