**ORDER**

As per the recommendation in the Ninth Pay Revision Commission approved vide GO read (2) and (3) above, 25% of the post of Junior Superintendent will be on Higher Grade on Rs 18740-33680/-. The authorized Strength of Junior Superintendents in NCC Department is 50 and hence 12 senior most Junior Superintendents are eligible for Ratio/Percentage based grade promotion.

2. Consequent to the retirement of Sri MK Vasudevan ,Junior Supdt, (HG),Shri PK Shaji, Jr. Supdt. (HG) and Shri CM Sunny, Jr .Supdt. (HG) wef 01.06.2014, four vacancies of Ratio/Percentage based Grade promotion will be available in the NCC Department.
