Cases related in seeking sanction of the competent financial authority for having held excess cash in hand during various NCC camps as per reference read as (b) above have been processed and while scrutinising these cases , the Additional Director General NCC expressed his great concern in the following :-

2. Though there is an existing and very clear directives of Camp Accounting vide ref read as (b ) above , violating this rule without obtaining prior sanction through telephonic conversation even , is not justifiable and excusable . It is needless to mention that once the comp account is kept ON , standard propriety of related rules are to be exercised in its whole spirit.

3. In the circumstances above , directives of Additional Director General NCC is hereby issued that explanation with justification from all Camp Commandants sought for sanction for having held excess cash during camp be submitted for perusal and further action .
