ORDER

As per the recommendation in the Ninth Pay Revision Commission approved vide GO read (2) and (3) above, 25% of the post of Junior Superintendent will be on Higher Grade on Rs 18740-33680/-. The authorized Strength of Junior Superintendents in NCC Department is 50 and hence 12 senior most Junior Superintendents are eligible for Ratio/Percentage based grade promotion.

2. Consequent to the promotion of Sri Viswanadha Pillai, Junior Supdt, (HG) and Sri TK.Valsalan, Junior Supdt,(HG) wef 27.11..2015 two vacancies of Ratio/Percentage based Grade promotion is available in this Department.

As per the seniority list of Junior Superintendents Sri Satheesh Sam Jose ,jr Supdt ,2(K) Bn NCC is the next senior most Jr Supdt and he is not qualified for getting this Ratio based Higher Grade Promotion. As such one vacancy is kept pending and sanction is hereby accorded for one Ratio Based /Percentage based Grade promotion to the next Senior Most Junior Supdt as per details given below.
