**ORDER**

This Directorate ordered by transfer appointment in r/o two Low Pay Scale Employees in this Department vide this Directorate proceedings cited 3<sup>rd</sup> above. Government vide order read 4<sup>th</sup> paper above, ordered that by transfer promotion/ appointment shall be made from a state wide seniority list of qualified low pay scale employees of the Department. Accordingly, a state wide final seniority list of Low Pay Scale Employees in this Department who were applied for by transfer promotion/ appointment to the post of LDC/LDT was published vide reference cited 6<sup>th</sup> above, as per Government order cited 4<sup>th</sup> above and the cadre strength of LDC & LDT was also revised & published vide proceedings cited 5<sup>th</sup> above.

2 On verification of vacancies arosed from 03.01.2014 in the cadre of LDC and LDT, 06 LDC and 02 LDT posts can be set apart for 10 by transfer appointment from Low Pay Scale Employees in this Department. Two Low Pay Scale Employees have already been promoted to the post of LDC vide Proceedings cited 3<sup>rd</sup> above and remaining 04 LDC vacancies and 02 LDT vacancies are filled from the qualified senior most low paid employees in the state wide final seniority list as below:-
