**ORDER**

As per reference 4<sup>th</sup> above, this Directorate ordered redeployment of civilian staff from the nearby units for the raising of 33 (K) Bn NCC, Nedumkandam as per GO read 1<sup>st</sup> and 2<sup>nd</sup> above till posts are sanctioned by the State Government.

Numerous applications have been received from the redeployed staffs to cancel the redeployment ordered vide proceedings cited above and Smt.Animol John, SGT has expressed her willingness to join in 33 (K) Bn NCC, Nedumkandam against Sri. Johnson Kuruvilla, LDT, 17 (K) BN NCC.

In the aforesaid circumstances, the undersigned is pleased to cancel the redeployment ordered in respect Sri. Johnson Kuruvilla, LDT, 17 (K) Bn NCC and Smt.Animol John, SGT, 17 (K) Bn NCC is hereby nominated in place of Sri.Johnson Kuruvilla, LDT vide letter cited 5<sup>th</sup> above. It is also intimated that the redeployment of civilian staffs ordered vide proceedings cited 4<sup>th</sup> above is limited for a period of 12 months from the date of joining in 33 (K) Bn NCC, Nedumkandam. Therefore requests for cancellation of redeployment at Nedumkandam are not being considered and they have to report for duty as directed by the proceedings cited without further delay. Pay and allowances of the redeployed employees should be drawn and distributed from their parent units. Those who obtained stay order from the Hon' KAT are directed to join after the expiry of the stay period.

The Group commanders/ Commanding Officers concerned are directed to relieve the redeployed employees with immediate effect and forward the completion report at the earliest.
