**ORDER**

This Directorate vide proceedings read 1<sup>st</sup> above prepared a select list for “by transfer promotion” to the post of SMSK and vide proceedings read 2<sup>nd</sup> above issued orders to appoint Sri. Moncy Alex O John, O/A of 9 (K) Bn NCC and Sri. Manikandan Nair B, Lascar of 1 (K) NU NCC as SMSK and post them to 7 (K) NU NCC and 1 (K) NU NCC respectively in the existing vacancies. Sri. Manikandan Nair, Lascar of 1 (K) NU NCC assumed charge as SMSK wef 09 Jul 2013 (F/N), and Sri. Moncy Alex O John, OA of 9 (K) Bn NCC has not joined duty.

2      Govt vide 4<sup>th</sup> paper above had directed to cancel the rank list prepared by this Department for selection to the post of SMSK, since the Boat Keepers included in the list were found not eligible for promotion to the said post as both posts come under the Kerala General Subordinate Service, Miscellaneous posts in the NCC Establishment. This Department vide proceedings read 5<sup>th</sup> above cancelled the promotion orders issued vide Proceedings cited 2<sup>nd</sup> above and Sri. Manikandan Nair B, SMSK was reverted to the post of ‘Lascar’ and posted to 1 (K) Air Sqn NCC, Thiruvananthapuram in the existing vacancy.

3.      The proceedings cited 5<sup>th</sup> was challenged by Sri.Manikandan Nair B, SMSK before Hon'ble Kerala Administrative Tribunal. The Hon'ble Tribunal quashed the proceedings and based on the said order of KAT cited at 6<sup>th</sup> above, Govt have directed this Department to fill the vacant posts of SMSK by appointing qualified hands as directed by Hon'ble KAT. The select list prepared vide letter read 1<sup>st</sup> above has been modified as per this Department proceedings read 7<sup>th</sup> above, taking into consideration KAT orders and Govt. directions in the matter.

4. In the aforesaid circumstances Sri.Manikandan Nair B, SMSK is reinstated in the post of SMSK.

**ORDER**

This Department prepared a select list for the appointment of SMSK vide reference cited 1<sup>st</sup> above and appointed Sri.Moncy Alex O John and Sri.Manikandan Nair B as SMSK vide proceedings cited 2<sup>nd</sup>. Sri.Moncy Alex O John did not join duty as SMSK. The select list and the appointments made from the select list was cancelled by this Department vide proceedings cited 3<sup>rd</sup> above due to the inclusion of Boat keepers in the select list as the Boat keepers were found ineligible for the appointment as SMSK.

2. The proceedings cited 3<sup>rd</sup> were challenged by one of the candidates before Hon'ble Kerala Administrative Tribunal. The Hon'ble Tribunal passed the orders to remove the unqualified persons included in the select list. Govt. vide their letter referred 5<sup>th</sup> above have directed to fill the vacant posts of SMSK by appointing qualified hands. The Boat keepers have been removed from the select list and fresh selection list published vide read 6<sup>th</sup> above.

3. Three vacancies of SMSK are available for by- transfer appointment. In the aforesaid circumstances, the remaining candidates in the selection list published vide proceedings read 6<sup>th</sup> above are hereby appointed as SMSK by transfer from other service Rs 9190-15780/- and posted to the units as below:-

**ORDER**
