**AWARDING OF GRACE MARKS TO THE NCC CADETS IN THE VHSE
EXAMINATION FOR THE YEAR 2015**

1. As per Govt of Kerala Orders No. GO(MS) 106/2005/G.Edn dated 04-04-2005 and GO(MS) 396/2005/G.Edn dated 27-10-2005 NCC Cadets who fulfill the following criteria are eligible for 10% grace marks in the VHSE Examinations. The last date of application received in unit on **20 Feb 2015**.

- (a) Passed "A" / "B" Certificate Examination.
- (b) Represented the State at RDC/IDC/BLC/NSC/VSC/TSC/RCTC/NIC/ALC/ All India Trekking Expedition any one (10%)
- © Held the rank of Corporal or its equivalent and above.

2. An also requested that the NCC Cadets who fulfill the following criteria are eligible for 5% grace marks in the VHSE Examinations vide GO (MS) No 125/12/G.Edn dated 20.04.2012. The last date of application received in unit on **20 Feb 2015**.

3. Applications are invited from the eligible NCC Cadets for award of grace marks in the VHSE Examinations during the current academic year. All COs are requested to obtain applications from the eligible Cadets in the prescribed proforma as per appendix "A" along with copies of attested NCC certificates including copy of VHSE Examination Hall Ticket. Hall Ticket duly attested by Principal in **four copies** and forward **three** to their respective Group Headquarters. Group Commanders are requested to consolidate and forward **two** copies of applications to this Directorate duly completed on or before **02 Mar 2015**. **The following points be ensured before applications forwarded to Dte:-**

- (i) Veracity of documents supported is verified as per records.
- (ii) Details of the Cadets are verified from Enrolment form.
- (iii) Ensure applications are forwarded district wise only for VHSE.
- (iv) Nominal roll of cadets are to be forwarded directly to this Directorate in excel worksheet prepared by unit as per proforma attached in appendix 'B' for 5% and 10% separately to this email Address;: gracemarkplustwo@gmail.com
- (v) Ensure eligible applications are forwarded in duplicate to this Directorate on or before **02 Mar 2015**
- (vi) Consolidate / Individual Attendance Certificate of cadets to be attached for 5% Grace Marks.


