ORDER

The Group Commander NCC Group Headquarters, Kottayam vide their letter read as 4th paper above has forwarded an application received from Sri.Rajesh G, Clerk regarding anomaly in final seniority list published vide this Directorate proceedings read 2nd paper above. The individual claims his seniority above Sri.Madhusoodhanan PG, Sr.Clerk, 14 (K) Bn NCC, Pathanamthitta (Which was not represented by the individual while published the provisional Seniority list of Clerks). On Scrutiny of the available documents, the representation is found correct and this Directorate vide letter read 5th paper above informed the above matter to Sri.Madhusoodhanan PG, Sr.Clerk, 14 (K) Bn NCC, giving 07 days time to represent objections if any. No objection has been received on above subject. Therefore, the undersigned is pleased to revise the date of promotion ordered in respect Sri.Rajesh G and Sri.Madhusoodhanan PG as per modified promotion list given below.

2. Also the promotion vacancy of Sri. Babu P, Senior Clerk, 32 (K) Bn NCC, Payyannur, the first vacancy of Senior Clerk in proceedings cited 4th above had already given to the category change of Sri.Rajendran K, UD Typist to Senior Clerk vide proceedings cited 3rd. The vacancy of Sri.Rajan K, Senior Clerk (Second Vacancy of Senior Clerk in proceedings cited 4th above) is also not considered as vacancy, since the individual has retired from service while on LWA. The same vacancies have been erroneously included in the previous promotion order of Sr.Clerks. Consequent on rejoining of Smt.Roshni Thomas from LWA on 25.01.2016 the strength of Senior Clerks in this Department exceeds by 01 and same is also adjusted in this proceedings against the vacancy of Sri.Akbar KK retired on 29.02.2016.


