**REVISION OF RATE OF HONORARIUM IN RESPECT OF ANO'S – IRREGULAR  
DEMAND - : REGARDING**

1. Reference:-
  - (a) Government of India, Ministry of Defence letter No. 3372/HON/DG NCC/ P&F (Coord)/ 724/ D (GS)- VI/ 2015 dated 24 Jul 2015
  - (b) Government Order GO (Rt) No.3416/16/H.Edn dated 15 Dec 2016 forwarded vide this Directorate letter No.6540/P3-Pub/2016/NCC(I) dated 27 Dec 2016.
2. It is observed with great concern that, the NCC Units are demanding Government funds on revised rate of honorarium, undue delay in processing in a haphazardical and disorganized manner resulted in for financial sanction.
3. In this connection, it is reiterated that the Government of India, Ministry of Defence and Government of Kerala have been pleased to revise the rate of honorarium in respect of ANO's of various educational institutions in the ratio of 50:50 respectively. The effective date of enhanced rate of honorarium will be admissible w.e.f from the date of issue of Government orders, as follows

**CENTRAL GOVT SHARE**

The Government of India, Ministry of Defence have been pleased to revise the rate of honorarium in respect of ANO's with effect from **24 Jul 2015**, as per the Order referred at Para 1 (a) above. The expenditure of the Central Govt share will be debited to Major Head 2076, Minor Head – 113 Sub Head F2.

**STATE GOVT SHARE**

The Government of Kerala have been pleased to revise the rate of honorarium in respect of ANO's with effect from **15 Dec 2016**, as per the Order referred at Para 1 (b) above. Accordingly revised rate of State share is admissible from 15 Dec 2016 only. It may be noted that till 14 Dec 2016 old rates will prevail. Demands should be placed accordingly. The expenditure of the State Govt share will be payable from Head of Account 34 Other Charges (Non-Plan)


