ORDER

As per the recommendation in the 10th Pay Revision Commission approved vide GO read (1) above, one third posts of Junior Superintendents will be on Higher Grade on ₹ 35700-75600/- and set apart 16 posts of Junior Superintendent of this Department for Junior Superintendent Higher Grade promotion. Government as per the GO read as 2nd paper above have accorded sanction for creation of 12 permanent posts including one Junior Superintendent for 33 (K) Bn NCC, Nedumkandom. Therefore, the sanctioned post of Junior Superintendents in this Department has been raised to 51 and hence 17 senior most Junior Superintendents are eligible for Ratio/Percentage based grade promotion in this Department vide GO cited 1st.

2. Consequent on promotion of Sri.Satheesh Sam Jose, Junior Superintendent (HG) to Manager and due to the retirement of Sri.S. Ravindran, Junior Superintendent (HG), 14 (K) Bn NCC, Pathanamthitta wef 30.06.2017, two more vacancies of Junior Superintendent (HG) arose in this Department wef 29.06.2017 and 01.07.2017 respectively. As such, three senior most Junior Superintendents may be promoted to the post of Junior Superintendents (HG).

3. As per the seniority list, following Senior most Junior Superintendents are eligible for the ratio based higher grade promotion in the cadre of Junior Superintendent (HG). As such, sanction is hereby accorded for Ratio Based /Percentage based Higher Grade promotion for the above three vacancies to the following Junior Superintendents in the cadre of Junior Superintendent (HG) on ₹ 35700-75600/- wef the date shown against them :-
