**ORDER**

One vacancy of Junior Superintendent arose in this Department as on 06 April 2017 against Smt.Sreekala NS, Junior Superintendent (HG), NCC Directorate (K&L), Thiruvananthapuram promoted as Manager.

2. The promotion in respect of Sri. Stephen VD, Senior most Head Clerk, NCC Directorate (K&L), Thiruvananthapuram has not been considered in this promotion order since major disciplinary proceedings has been initiated against him.

3. In order to fill up the aforesaid vacancy, following postings/promotions in the cadre of JS and HC are ordered with immediate effect:-


