AWARDING OF GRACE MARKS TO THE NCC CADETS IN THE VHSE
EXAMINATION FOR THE YEAR 2017

1. As per Govt of Kerala Order No. GO(MS) 106/2005/G.Edn dated 04.04.2005. NCC Cadets who fulfill the following criteria are eligible for 10% grace marks in the VHSE Examination. The last date of receipt of application in the units is on **25 Feb 2017** :-
 - (a) Passed "A"/"B" Certificate Examination.
 - (b) Represented the State at RDC/IDC/BLC/NSC/VSC/TSC/RCTC/NIC/ALC/All India Trekking Expedition any one (10%).
 - (c) Held the rank of Corporal or its equivalent and above.
2. It is also intimate that the NCC Cadets who fulfil the following criteria are eligible to 5% grace marks in the VHSE Examination vide GO(MS) No. 125/12/G.Edn dated 20.04.2012.
3. Applications are invited from the eligible NCC Cadets for award of grace marks in the VHSE Examinations during the current academic year. All Cos/OsC are requested to obtain applications from the eligible Cadets in the prescribed Performa as per appendix "A" & "B" along with attested copies of NCC certificates including **four copies** of VHSE Admission Ticket (Hall Ticket) duly attested by Principal and forward **three copies** to their respective Group Headquarters on or before **28 Feb 2017** (One be retained at the unit). Group Commanders are requested to consolidate and forward two copies of applications to this directorate duly completed on or before **04 Mar 2017**. **The following points be ensured before application are forwarded to Dte :-**
 - (a) Instructions issued vide the Dte letter under reference is strictly adhered to.
 - (b) Veracity of documents supported is verified as per records.
 - (c) Details of the cadets are verified from Enrolment form.
 - (d) Ensure applications are forwarded district wise only of VHSE.
 - (e) Ensure eligible applications are forwarded in duplicate to this Directorate on or before **05 Mar 2017**.
 - (f) Consolidate/individual/Attendance Certificate of cadets to be attached for 5% Grace Marks.
4. Necessary instructions be given to all ANOs of institution to submit the application thoroughly scrutinized well in time to enable Directorate to forward the same to Director of Vocational Higher Secondary Education before last date so that the cadet can avail the facility as authorized by Govt.
