ORDER

Sri.Chandrabhanu PM, Sr.Clerk, 31 (K) Bn NCC was promoted as Head Clerk and posted to 1 (K) Girls (I) Coy NCC, Cherthala vide proceedings cited 3rd above. . The Group Commander, Kozhikode vide letter referred 4th above has forwarded an application received from Sri.Chandrabhanu PM, Sr.Clerk requesting for relinquishment of his promotion in the cadre of Head Clerk due to domestic problems. In the view of the above, the undersigned is pleased to accept the relinquishment made by Sri.Chandrabhanu PM, Sr.Clerk, 31 (K) Bn NCC. The date of relinquishment of his promotion to the cadre of Head Clerk will come into force from the date his immediate junior assumes charge in the cadre of Head Clerk.

2. In the above circumstances, the next senior most Senior Clerk may be considered for promotion to the post of Head Clerk in the relinquished vacancy. And also one more vacancy of Junior Superintendent will arise in this Department wef 01.10.2017 against the vacancy of Sri. Satheesan Pillai, Junior Superintendent, 3 (K) Bn NCC retiring on 30.09.2017.

3. In order to fill up the aforesaid two vacancies, following promotions in the cadre of JS and HC's are ordered with immediate effect:-
