**ORDER**

The Group Commander NCC Group Headquarters, Ernakulam vide their letter read as 6<sup>th</sup> paper above has forwarded an application from Sri.Sudhakaran K, Clerk, NCC Group Headquarters, Ernakulam for promotion as Senior Clerk since his date of reckoning seniority has been revised to 01.06.2011 instead of 22.06.2012 by this Directorate vide proceedings read as 3<sup>rd</sup> paper above based on Government decision.

2. The probation in respect of Sri.Prasannarajan B, Clerk, 7 (K) NU NCC, Ernakulam has been declared wef 11.02.2016 vide this Directorate proceedings read 5<sup>th</sup> paper above. Therefore, the individual became eligible for promotion to Senior Clerk after the date of declaration of probation based on seniority.

3. In the above circumstances, the promotion of Clerks to Senior Clerks ordered vide this Directorate proceedings read 4<sup>th</sup> paper above to be reviewed in light of the above. On scrutiny, it is found that due to the revision of seniority in respect of Sri.Sudhakaran K , Clerk, NCC Group Headquarters, Ernakulam he has to be promoted as Senior Clerk wef 01.06.2016 and placed above Sri.Anilal DR, Senior Clerk (SI No.13 in proceedings read 3<sup>rd</sup> above). Also, Sri. Prasannarajan B, Clerk, 7 (K) NU NCC has to be promoted as Senior Clerk and placed above Sri.Sudharakan M, Senior Clerk 9 (K) Bn NCC, Kottarakkara (SI No.19 in proceedings read 3<sup>rd</sup> above) consequent to the declaration of probation wef 11.02.2016.
