ORDER

In the light of the orders issued by the 1100 Directorate to the effect that all Civilian Staff employees detailed for the Camp duty must stay and work there for the 24 hours during the entire period of the duty, the 1100 Civilian Staff Association and the H.E.D. Front in their respective pleadings as first and second papers above requested Government to grant compensatory leave to the Civilian Staff of 1100 during holiday(s).

Government having considered their request in all its aspects have found that it is not correct to say that the Civilian Staff of 1100 Department attending camp duty on holidays could be treated as Government Servants working on public holidays (vide condition (vi) of Section III Appendix VI, Part I RSR) Government Servants on tour need not necessarily work on holidays whereas the Civilian Staff of 1100 Department on Camp duty have to work on holidays. Generally D.A. is allowed to staff of all departments during holidays. The case of civilian staff of 1100 Department is different since they have to work on holidays since the camps are held invariably on holidays.

In the above circumstances Government are pleased to order that 1100 Civilian Staff working on holidays during camp duty are eligible to all compensatory leave in relation of condition No. (vi) of Section III, Appendix VI of Part I RSR.
