ORDER

Sri.Stephen VD, Head Clerk, 1 (K) Arty Bty NCC, Thasassery had been accused of misappropriation of State/Public/Regimental fund account of 31 (K) Bn NCC, Kannur while the individual was in charge of accounts section of 31 (K) Bn NCC. The case was ~~been~~ reported by the Group Commander, Kozhikode. After conducting a proper Inquiry, disciplinary case was initiated and punishment was awarded vide this Directorate proceedings at reference 1 above.

2. Now, the Officer Commanding, 1 (K) Arty Bty NCC, Thalassery vide reference cited at 2 above forwarded a Show Cause Notice issued to Sri.Stephen VD, Head Clerk reporting that the individual is once again involved in misappropriation of funds amounting to Rs.35924/- (Rupees Thirty Five Thousand Nine Hundred and Twenty Four Only). Subsequently, this Directorate sent a Departmental Audit team to conduct audit of funds and connected documents at 1 (K) Arty Bty NCC, Thalassery. Based on the report submitted by the Audit Team, it is revealed that Sri.Stephen VD, Head Clerk presently holding the post of DDO at 1 (K) Arty Bry NCC has once again involved in misappropriation of funds, without exercising financial prudence, by misusing the DDO privilege held by him.

3. In the above circumstances, Sri.Stephen VD, Head Clerk, 1 (K) Arty Bty NCC, Thasassery is hereby suspended from service with immediate effect pending disciplinary proceedings as per Rule 10 (a) of KCS(CCA) Rules 1960.

4. Sri.Stephen VD, Head Clerk will be paid subsistence allowance as per existing rules.


