NCC Department -Establishment – Revocation of suspension, reinstatement and reversion - Head Clerk/ Senior Clerk- Orders issued.

ORDER

1. A case of misappropriation of fund of Rs 35924/- was reported by CO,1(K)Arty Bty NCC,Thalassery vide reference cited 1st above against Sri Stephen VD, Head Clerk,1(K)Arty Bty NCC who was holding the DDO charge of that unit. In pursuance of the said report, a departmental audit was conducted and based on the audit report Stephen VD, Head Clerk,1(K)Arty Bty NCC was suspended from service wef 21/5/2018 vide this Dte proceedings cited 3rd above pending disciplinary proceedings.

2. Subsequently an enquiry was conducted and MOC issued to Sri Stephen VD. In reply to the Memo of Charge issued to him , he replied that he has refunded the entire amount of Rs. 35924/- to regimental fund even though delay occurred. As the period of suspension of six months expired on 20/11/18, his suspension should be revoked and be reinstated in service as HC pending disciplinary proceedings as per Rule 10(a) of KCS(CCA)Rules 1960.

3. Though he was earlier promoted as Junior Superintendent wef 01/05/18 vide this Dte proceedings cited 2nd above he was not allowed to assume charge as JS due to above suspension. Since he did not assume the charge of JS, he could be reinstated only as HC when suspension revokes.

4. In the aforesaid circumstances, the suspension of Sri Stephen VD, Head Clerk 1(K)ARTY Bty NCC is hereby revoked and he is re-instated in service as Head Clerk and posted to NCC Directorate, TVPM with immediate effect.

5. To accommodate Sri Stephen VD, Head Clerk, Smt. Divya Suresh, Head Clerk, NCC Directorate is hereby reverted as Senior Clerk and posted to NCC Directorate, TVPM in connection with order cited 4th above.

6. Necessary entries will be made in the service book of the individual concerned under proper attestation and TA/DA and joining time is admissible as per rules.



7. The actual date of relief / joining duty should be reported to this Directorate immediately.
