

NCC QUOTA FOR PROFESSIONAL DEGREE AND ALLIED COURSES- 2019
COMPLAINTS BY CADETS & PARENTS.

1. This Dte has received few complaints in this academic year from cadets and parents regarding unprofessional/ irresponsible behavior and insensitive action by Office Staff at Units level. In some cases cadets have lost the opportunity to avail NCC Quota for higher education. This reflects very poorly on the image of NCC Dedicated hard work of many staff would get maligned by unscrupulous behavior of few individuals. Therefore there is requirement of ensuring a more sensible efficient work culture and work discipline in the Units.
2. Details of complaint received are attached at Appendix. Gp Cdrs are requested to investigate each case by contacting the cadets/ their parents and fix responsibility for the lapse. Investigation report will be forwarded to this Dte for information of ADG by 15 Jul 2019 without fail.
3. It has also come to notice that ANOs are not briefed by units on the procedures of processing the applications leading to confusion and misguidance. In many cases after obtaining the signature of ANO, Cadets are directly forwarding applications to Dte without recommendation of Unit/Gp HQs and thus become ineligible for consideration. Gp Cdrs are requested to direct OsC to conduct proper briefing to ANO's and to cadets on how to process applications.
