**ORDER**

1. One vacancy of Junior Superintendent is existing in 33(K) BN NCC Nedumkandam since the transfer and promotion ordered vide this Dte proceedings cited 3<sup>rd</sup> could not be implemented fully at that time due to the partial stay in OA cited 4<sup>th</sup> above. Now that the Govt vide order cited 5<sup>th</sup> above has taken appropriate decision on above OA as per the direction from the Honorable KAT in respect of above OA, and the subject case is closed. In view of the aforesaid the following promotion and posting of JS and HC is ordered with immediate effect:-

- (a) **Sri Nazar A**, Senior most Head Clerk (PEN 396199), NCC Dte TVPM is provisionally promoted to the cadre of Junior Superintendent in the scale of pay of 30700-65400/- and posted to 33(K)BN NCC,Nedumkandam in the existing vacancy. He earlier vide his application dated 15/10/19 requested for relinquishment of promotion to the post of JS and subsequently cancelled it vide his application dated 11/12/19.
- (b) **Sri Sunilkumar SS**, The **senior most** Senior Clerk (PEN 409417), NCC Dte TVPM is provisionally promoted to the cadre of Head Clerk in the scale of pay of 27800-59400/- and posted to NCC Dte TVPM in the vacancy of Sri Nazar A promoted as JS.
- (c) **Sri Stalin S**, Senior Clerk (PEN313471) , 3(K) Girls BN NCC is provisionally promoted to the cadre of Head Clerk in the scale of pay of 27800-59400/- and posted to 1(K)Arty Bty,Thalassery in vacancy of Sri Rajeev KP who is promoted as JS..

2. Necessary entries will be made in the service book of the individual concerned under proper attestation.

4. All promotees will be under probation for a period of one year on duty within a continuous period of two years of service.
