ORDER

1. 3. The undersigned has examined the matter in detail and is pleased to order the re-deployment of Sri Latheesh OP, Junior Superintendent of NCC Group Headquarters, Ernakulam for the newly raising Unit at Mananthavadi, Waynad.

6. The pay and allowances of the re-deployed employee should be drawn and distributed from his parent Office. The redeployment of civilian staffs as mentioned in this order is limited for a period of 12 months from the date of joining at 5 (K) Bn NCC, Mananthavadi.
