ORDER

1. As per GO read as 1st above, Govt reserved 10% of vacancies of LDC/LD Typist of any department for the eligible employees of Last Grade Servants of that Department. As per GO read as 2nd above was issued to give more clarity to the 1st GO regarding cadre strength, date of effect of order etc. As per the GO read as 3rd above, Govt ordered to reserve 10% vacancy to be set apart for by transfer appointment from low paid employees from state wide vacancies, if it cannot be set apart district wise. As per GO read as 5th paper above, Govt have rescinded the conditions at para 2 (ii) in GO read as 2nd paper above. Govt vide their letter read as 6th paper above directed that to implement the GO read as 1st paper above, actions must be taken as described in the GO read as 2,3 & 4th above. The matter was examined in detail and this office has fixed cadre strength for the post of Clerk in regional wise vide proceedings read as 7th paper above.

2. Accordingly, this Office had invited applications for by transfer appointment to the post of Clerk from the low paid employees vide letter read as 8th paper above and published regional wise final seniority list vide proceedings read as 9th paper above.

3. Sri Mohanan A, Attender Gde-II of NCC Dte (Sl.No 1 of the seniority list of low paid employee of TVPM Group) has submitted unwillingness to join duty as Clerk vide ref read as 10th paper above.
