**ORDER**

Consequent to retirement of Sri. Muraleedharan P, SMSK 7(K) Naval Unit NCC, one vacancy of Ship Modeling Store Keeper has arisen in 7(K) Naval Unit NCC, Ernakulam. In order to fill up the vacancy by Transfer appointment from lower categories, this directorate as per letter read as 1<sup>st</sup> paper above had invited applications from all eligible candidates of this department for by transfer appointment to the post of SMSK and no applications were received till the last date of receipt of applications.
