NCC Department – By transfer appointment from Low Paid Employees to the post of Clerk on the scale of pay of Rs 26500-60700 – Acceptance of Relinquishment and appointment - orders issued.

**ORDER**

1. As per GO read as 1<sup>st</sup> above, Govt reserved 10% of vacancies of LDC/LD Typist of any department for the eligible employees of Last Grade Servants of that Department. As per GO read as 2<sup>nd</sup> above was issued to give more clarity to the 1<sup>st</sup> GO regarding cadre strength, date of effect of order etc. As per the GO read as 3<sup>rd</sup> above, Govt ordered to reserve 10% vacancy to be set apart for by transfer appointment from low paid employees from state wide vacancies, if it cannot be set apart district wise. As per GO read as 5<sup>th</sup> paper above, Govt have rescinded the conditions at para 2 (ii) in GO read as 2<sup>nd</sup> paper above. Govt vide their letter read as 6<sup>th</sup> paper above directed that to implement the GO read as 1<sup>st</sup> paper above, actions must be taken as described in the GO read as 2,3 & 4<sup>th</sup> above. The matter was examined in detail and this office has fixed cadre strength for the post of Clerk in regional wise vide proceedings read as 7<sup>th</sup> paper above.

2. Accordingly, this Office had invited applications for by transfer appointment to the post of Clerk from the low paid employees vide letter read as 8<sup>th</sup> paper above and published regional wise final seniority list vide proceedings read as 9<sup>th</sup> paper above.

3. In the extent, this Directorate issued appointment order to the eligible senior most Low paid employees for the post of clerk in the reserved vacancies vide this Directorate order read as 10<sup>th</sup> paper above. Among them, Sri Jayakumar K, Office Attendant Gde-I of 14 (K) Bn NCC who got appointment as clerk through by transfer appointment and posted at NCC Group Headquarters, Kottayam has expressed his unwillingness to join duty as Clerk in the posted office due to some domestic problems. Individual submitted documents pertains to the relinquishment of promotion temporarily vide ref read as 11<sup>th</sup> paper above.

4. The matter has been examined in detail, the request for relinquishment of Sri Jayakumar K, is hereby accepted. In order to fill the above vacancy, Sri Binu MP, PEN 716856, Lascar Gde-I of 14 Kerala Bn NCC, who is the next eligible senior most is hereby appointed as Clerk under by transfer appointment from Low paid employees in the scale of pay of Rs 26500-60700 and posted to **NCC Group Headquarters, Kottayam** in the existing vacancy.

5. He will be on probation in the cadre of Clerk for a period of two year on duty with in a continuous period of three years from the date of join of duty as Clerk vide para 4 (I) of GO (P) No 17/2018/P&ARD dated 27 Dec 2018.

6. The original educational qualification certificates should be verified by the Head of Office of respective Gp HQ/ Units to where individual is being posted. The incumbent who is not willing to join duty as clerk will be submitted the unwillingness to this Directorate through proper channel with in 10 days from the date of receipt of this order.

7. Necessary entry will be made in the Service Book of the incumbent under proper attestation and date of joining duty should be intimated. All head of Offices are requested to relieve the above employees so as to enable them to join the duty in the appointed post of Clerk in the scale of Rs 26500-60700.
