ORDER

1. NCC Group Headquarters, Ernakulam vide reference 2nd cited above have placed TR-59(C) demand for **Rs. 39,600/- (Rupees Thirty nine thousand and six hundred only)** for allotment of funds towards the payment of Caretaker allowance/OMA to Caretaker/ANO's of Schools and Colleges of **21 (K) Bn NCC, Ernakulam** for the financial year 2020 - 2021. The same could not be passed during previous financial year due to late submission of claim.
