ORDER

1. NCC Group Headquarters, Ernakulam vide reference 2nd cited above have placed TR-59(C) demand for **Rs. 23,400/- (Rupees Twenty three thousand and four hundred only)** for allotment of funds towards the payment of OMA to ANOs of Schools and Colleges of **22 (K) Bn NCC, Eloor** for the financial year 2020-2021.
