**ORDER**

1. NCC Group Headquarters, Ernakulam vide reference 2<sup>nd</sup> cited above have placed TR-59(C) demand for **Rs. 28,800/- (Rupees Twenty eight thousand and eight hundred only)** for allotment of funds towards the payment of OMA to ANOs of Schools and Colleges of **7 (K) Naval Unit NCC, Ernakulam** for the financial year 2020-2021.
