**ORDER**

1. NCC Group Headquarters, Kottayam vide reference 2<sup>nd</sup> cited above have placed TR-59(C) demand for **Rs. 34,200/- (Rupees Thirty four thousand and two hundred only)** for allotment of funds towards the payment of OMA to ANO's of 18 (K) Bn NCC, Muvattupuzha for the financial year 2020 - 2021.
