1. NCC Directorate letter read as 1st, 2nd and 3rd directed all Group HQs and Units to limit monthly Electricity consumption and ensure not to exceed the ceiling limit as fixed as ₹9,000/- for Group HQs and ₹4,500/- for Units.
2. On verification of monthly Electricity usages as per KSEB Bill No read as 4th, Additional Director General NCC (K&L) observed that usage of electricity beyond their authorized limit by following Units:-
