NCC Dept – Establishment –Ratio/Percentage based Grade Promotion of Sri.Aji CK, Senior Superintendent – Sanctioned – Orders issued.

ORDER

1. As per the recommendation in the 10th Pay Revision Commission approved vide GO read above, 25% of the post of Senior Superintendent will be on Higher Grade on scale of pay of Rs.40500-85000/-. Total 07 Senior Superintendents/Manager are authorized in NCC Department and one Senior most Senior Superintendent/Manager is eligible for Ratio/Percentage based Grade Promotion. Consequent up on the retirement of Smt.Sulabha AN, Manager (HG) Group Headquarters, Kottayam wef 30.04.2020 one vacancy of Senior Superintendent/Manager(HG) arose in this department wef 01.05.2020.
2. Govt vide letter citd 2nd above clarified that though Sri.Satheesh Sam Jose, Manger of NCC Group Headquarters, Thiruvananthapuram is the next senior most Senior Superintendents/Manager, but he is not eligible for granting Ratio/Percentage based Grade promotion since he has not yet completed his probation. He will be considered for grade promotion on completion of his probation. As per the final seniority list of Senior Superintendent as on 01/01/2020, Sri.Aji CK, NCC Directorate is the next senior most eligible senior superintendēnt and he is found eligible for Grade promotion.
3. Having satisfied the conditions for the grant of Ratio Based Grade Promotion under the provisions of the reference cited, the undersigned is pleased to grant the Ratio percentage Grade Promotion in the scale of Rs.40500-85000/- with effect from 01/05/2020 to Sri Aji CK, Senior Superintendent, NCC Directorate, Thiruvananthapuram who is the next eligible Senior most Senior Superintendent/Manager. This is subject to reversion

depends on the probation declaration date of Sri.Satheesh Sam Jose,Manager subsequently in the final verdict in OA/1818/20 filed by him. The incumbent should submit undertaking as per G.O.(P) No.169/2019/Fin dated 13/12/2019.


