ORDER

1. In the GO read as 1st paper above, Govt had accorded approval in principle for raising of new NCC unit at Mananthavadi, Wayanad and vide GO read as 2nd paper above sanction was accorded to re-deploy the staff as mentioned below from any NCC unit for newly raised unit 5 (K) Bn NCC, Mananthavadi till posts are sanctioned by the State Government.

However Sri.Babu K, Clerk of this Directorate has expressed his willingness for re-deployment to 5 (K) Bn NCC, Mananthavadi vide ref cited 5th above.

3. In the above circumstances, the undersigned has examined the matter in detail and is hereby reverted Sri.Sathyanadhan K, Clerk of 5 (K) Bn NCC to NCC Group Headquarters, Ernakulam (Parent office) with immediate effect.
