**ORDER**

1. As per G.O read as 1<sup>st</sup> above, Government reserved 10% vacancies of LDC/LD Typist of any Department for the by transfer appointment of eligible employees of Last Grade Servants of the Department. Further G.O read as 2<sup>nd</sup> above was issued to give more clarity to the 1<sup>st</sup> G.O regarding cadre strength date of effect of order etc. As per the G.O read as 3<sup>rd</sup> above, Government ordered to reserve 10% vacancy to be set apart for 'by transfer' appointment from low paid employees from state wide vacancies, if it cannot be set apart district wise and can be appointed regional wise vide G.O cited 5<sup>th</sup> above.

2. Accordingly this office had published regional wise final seniority list of low paid employees vide proceedings read as 7<sup>th</sup> paper above and made appointments in the reserved vacancies kept aside for them. Further it was specified that the reserved vacancies left to be filled up in the Kollam, Kozhikode region will be filled as and when open vacancies arise in the said regions vide ref read as 8<sup>th</sup> above.

3. At present 02 vacancies have arisen in Ernakulam and Kollam region due to the retirement of Sri. Rejiladas N, clerk of 24 (K) Bn NCC wef 28 Feb 2022 and the retirement of Sri. Dhanapalan V, Clerk of 8 (K) Bn NCC wef 31 Mar 2022 respectively.
