**ORDER**

1. NCC Group Headquarters Kottayam vide reference 2<sup>nd</sup> cited above have placed TR-59(C) demand for **Rs. 7,54,237/- (Rupees Seven lakh fifty four thousand two hundred and thirty seven only)** for allotment of funds towards the payment of Refreshment Allowance/ Honorarium/ OMA to Cadets/ANOs of **14 (K) Bn NCC, Pathanamthitta**. Financial Sanction for **Rs. 7,54,237/- (Rupees Seven lakh fifty four thousand two hundred and thirty seven only)** was accorded vide reference 3<sup>rd</sup> cited. Due to financial restrictions imposed on BIMS/BAMS the same amount could not be released during financial year 2021-22.

In the above circumstances, proceedings referred 3<sup>rd</sup> above is hereby cancelled and fresh Financial Sanction is hereby accorded to the Officer Commanding, **14 (K) Bn NCC, Pathanamthitta** for further sub allotment of funds to the Educational Institutions through BAMS from the Financial Year 2022-2023, as listed below :-
