ORDER

1. NCC Group Headquarters Ernakulam vide reference 2nd cited above have placed TR-59(C) demand for **Rs. 1,35,106/- (Rupees One lakh thirty five thousand one hundred and six only)** for allotment of funds towards the payment of Honorarium/OMA to ANOs of **21(K) Bn NCC, Ernakulam** for the financial year 2021-2022. Financial Sanction for Rs. 1,35,106/- (**Rupees One lakh thirty five thousand one hundred and six only**) was accorded vide reference 3rd cited. Due to financial restrictions imposed on BIMS/BAMS the same amount could not be released during financial year 2021-22.
