**ORDER**

1. NCC Group Headquarters Kottayam vide reference 2<sup>nd</sup> cited above have placed TR-59(C) demand for **Rs. 2,52,900/- (Rupees Two lakh fifty two thousand nine hundred only)** for allotment of funds towards the payment of Refreshment Allowance to Cadets/ANOs of **33(K) Bn NCC, Nedumkandam** for the financial year 2021-2022. Financial Sanction for **Rs. 2,52,900/- (Rupees Two lakh fifty two thousand nine hundred only)** was accorded vide reference 3<sup>rd</sup> cited. Due to financial restrictions imposed on BIMS/BAMS the same amount could not be released during financial year 2021-22.

In the above circumstances, proceedings referred, 3<sup>rd</sup> above is hereby cancelled and fresh Financial Sanction is hereby accorded to the Officer Commanding, **33(K) Bn NCC, Nedumkandam** for further sub allotment of funds to the Educational Institutions through BAMS from the financial year 2022-2023, as listed below :-
