ORDER

1. NCC Group Headquarters Ernakulam vide reference 2nd cited above have placed TR-59(C) demand for **Rs. 2,69,603/- (Rupees Two lakh sixty nine thousand six hundred and three only)** for allotment of funds towards the payment of Refreshment Allowance/ Honorarium/ OMA to ANOs of **7 (K) Girls Bn NCC, Thrissur** for the financial year 2021-2022. . Financial Sanction for **Rs. 2,69,603/- (Rupees Two lakh sixty nine thousand six hundred and three only)** was accorded vide reference 3rd cited. Due to financial restrictions imposed on BIMS/BAMS the same amount could not be released during financial year 2021-22.

In the above circumstances, proceedings referred 3rd above is hereby cancelled and fresh Financial Sanction is hereby accorded to the Officer Commanding, **7 (K) Girls Bn NCC, Thrissur** for further sub allotment of funds to the Educational Institutions through BAMS from the financial year 2022-2023 , as listed below :-
