ORDER

1. Vide reference read as 3rd paper above, this Directorate has issued order for reversion of Sri Yoosaf P A, Lascar Gr-II to his parent unit i.e. 30 (K) Bn NCC, since the individual had already completed one year re-deployment and had requested for reversion. Also, in the ibid order Sri Sreejith PP, Lascar Gr-II of 30 (K) Bn NCC was detailed for re-deployment at 5 (K) Bn NCC. Now, Sri Sreejith PP has submitted an application through NCC Gp HQ, Kozhikode vide reference read as 4th paper to cancel his re-deployment at 5 (K) Bn NCC, Wayanad; on compassionate ground. Sri Yoosaf P A, Lascar Gr-II has now submitted an application through NCC Gp HQ, Kozhikode vide reference read as 5th paper above for extension of his re-deployment at 5 (K) Bn NCC, Wayanad for a further period of one year upto 15 Oct 2022.

In the above circumstances, the undersigned has examined the matter in detail and is pleased to order that the re-deployment of Sri Yoosaf P A, Lascar Gr-II of 30 (K) Bn NCC at 5 (K) Bn NCC, Wayanad is extended for a further period of one year upto 15 Oct 2022 and the re-deployment order of Sri Sreejith PP, Lascar Gr-II of 30 (K) Bn NCC to 5 (K) Bn NCC issued vide para 4 (c) of this Dte proceedings read as 3rd paper above is hereby cancelled.
3. The pay and allowances of the re-deployed employees should be drawn and distributed from their parent offices.
