ORDER

1. In the GO read as 1st above, Govt had accorded approval in principle for raising of new NCC Unit at Mananthavadi, Wayanad and vide GO cited 2nd accorded sanction to re-deploy the staff as mentioned below from any NCC Units for newly raised NCC Unit at 5 (K) Bn NCC, Mananthavadi till posts are sanctioned by the State Government.

(b)	Sri Rejiladas N Clerk	24 (K) Bn NCC Thrissur	Individual due for superannuation wef 28 Feb 2022 and required to be reverted back to parent unit for completing his pension documents.
(c)	Sri Jose PD Lascar Grade-I	9 (K) Naval Unit Kozhikode	Individual due for superannuation wef 31 May 2022 and required to be reverted back to parent unit for completing his pension documents.

3. This Directorate vide letters cited 3rd above called for willingness from individuals to be re-deployed to the post under Clerical & Lascar category, but no employees (Clerk & Lascar) have expressed their willingness for re-deployment to the newly raised unit at Wayanad.
