ORDER

As per Government Order 1st cited, Government have interalia ordered that an HBA applicant should have completed minimum 5 years service in Government for applying HBA from Government.

2. Government of India vide M.U.D. under reference 2nd has since extended the benefit of reckoning the past military service of re-employed military employees in civilian service for reckoning the minimum service required for applying HBA

3. Government are pleased to order that the past military service of re-employed military employees in civilian service under Government of Kerala Service would be counted for reckoning the minimum eligible period for applying HBA from Government of Kerala.

4. The G.O. under reference 1st stands modified to this extent.
