ORDER

1. The under mentioned candidate to whom Government sanction for appointment under the scheme for reappointment/regular appointment for physically handicapped persons recruited through Employment Exchange is received vide GO read above is provisionally appointed as Lascar Gde-II in Thiruvananthapuram District in the pay scale of Rs. 8500-13210/-. As stipulated in the Govt Order cited, the supernumerary post created for the purpose will stand abolished as and when the incumbent retires on superannuation.

The above mentioned candidate is directed to report to the Administrative Assistant of this Directorate **within 15 days** on receipt of this proceedings with necessary documents in original to prove his date of birth, qualifications and in case of candidate whose community is noted in the appointment order, his community certificate, Non – Creamy Layer Certificate etc also to be produced. He is also required to produce **a Medical Certificate** of health in original from a Medical Officer not below the rank of an Assistant Surgeon having MBBS Degree and **two character certificates from gazettes officers**, failing which they will not be admitted for duty.

4. The appointment of the candidate is temporary under Rule 9 (a) (i) of the General Rules of the Kerala State and Subordinate Service Rules 1958 as provided in the Rule 10 (b) of the above rules and also subject to satisfactory report in Police verification later regarding his character and antecedents. The service of the candidate is subject to Rule 3 (c) of the General Rules of the Kerala State and Subordinate Service Rules 1958.

5. He will be on probation in the cadre of Last Grade Servant for a period of one year on duty within a continuous period of three years from the date of joining duty.

6. The Head of Office concerned will obtain the endorsed proforma duly filled in by the candidate before he is allowed to join duty. If there is any discrepancy the candidate should not be allowed to join duty and the fact should be reported forthwith. The original community certificate, Non creamy layer certificate as applicable may be verified at the time of joining duty.

7. As per GO (P) No.20/2011/P&ARD dated 30.06.2011, the candidate is also directed to affix his thump impression on the medical fitness certificate along with an attested copy of photograph. Service book in respect of the individual may be opened within one week from the date of joining duty. Attested copies of pages of service book containing name, address, thump impression, signature and personal identification marks are to be verified along with photocopy of identification certificate and Joining report is to be forwarded to Social Justice Department.

8. The candidate should report for duty within 15 days on receipt of this order, failing which action will be taken to cancel the appointment without further notice.

Note: - 1. The Head of Office will obtain SPARK FORM No 1 duly filled for registering SPARK system to obtain Permanent Employment Number (PEN).

2 The Head of Office will obtain application for allotment of Permanent Retirement Account Number (PRAN) from the individual vide GO (P) No.149/2013/Fin dated 03.04.2013.


